

## Enrollment and Credentialing Application Status Inquiries

This document describes the process for a provider to contact a health plan regarding the status of a credentialing application including the signed contract necessary for provider enrollment. Providers should allow a reasonable amount of time to pass so that primary source verification and enrollment processes can be completed before your inquiry.

If your question is specific to the status of a credentialing application, you may access your application via the CAQH website (<https://upd.caqh.org/OAS/>). Once in your individual CAQH record, go to the Start tab and select Your Activity Log.
